SEECO Project Call for Supporting Social Procurement

Frequently Asked Questions

Question: Can each company that apply to the call be included in the process?

Answer: No. The declarations of the companies that filled the application form will be evaluated and the process will be carried out with the companies that signed the protocol.

Question: How will the facilities to be established within the criteria of the call be chosen in terms of location, line of products, and service extend?

Answer: It will be determined by considering the demands and consultancy of the companies with which the protocol is signed and the needs of the region.

Question: Can an individual apply for the Call for Supporting Social Procurement?

Answer: The Call for Supporting Social Procurement is a call for applications from companies interested in buying goods or services to be produced in the new facilities. It is not open to individual application.

Question: Will grant support be provided for the establishment of facilities?

Answer: Yes. Construction of the facilities' shared workspaces and the acquisition of shared machinery and production-related equipment will be supported with the help of the grant.

Question: Who will receive the grant support?

Answer: Grants will be given to institutions that will ensure the long-term sustainability of the facilities that will be established as part of the Call for Supporting Social Procurement. Individuals will be assisted with grant applications for the purchase of machinery and equipment for production at the facilities, which will be announced in the coming days.

Question: I have a company in the disaster area that was affected by the earthquake. Can I get grant support?

Answer: Yes, but grant support is not the subject of the Social Procurement call. This call has been announced to determine the companies that want to purchase the products and services to be produced in the facilities to be established in the region. In the coming days, you can apply for a grant by following the official channels of the SEECO Project and the 'Acceleration Grant' announcements of the Development Agency in your region.

Question: Will the applicant companies purchase machinery and equipment?

Answer: No. The purchase of machinery and equipment will be carried out by the project within the scope of grant support.

Question: What do business owners that submit applications and have those applications accepted ?

Answer: It undertakes to ensure that the products and services to be produced in the facilities to be established are at the expected standards and to purchase the products.

Question: Can newly established companies apply for the call?

Answer: No. This is a call to businesses that can currently make purchases of goods and services. Newly formed businesses can submit an application for a grant by adhering to the SEECO Project's official communication channels and the " Grant of Incubation " announcements made by the Development Agency in your area.

Question: Who addresses applications for the SEECO Project's 'Incubation Program Grant' and 'Acceleration Program Grant'?

Answer: The Incubation Grant Program focuses on beneficiaries who will start a business from idea to implementation, whereas the Acceleration Grant Program focuses on the growth and capacity expansion of existing businesses.
